SUBJECT: AUTHORIZATION TO EXERCISE IN STATE OF EMERGENCY;
DISASTER MOBILIZATION. DET 405.

1. COMMANDER, CDS DETACHMENT 405, OKLAHOMA CITY FORMALLY ISSUES EMERGENCY MOBILIZATION OF ALL AVAILABLE PERSONNEL TO REPORT AND MUSTER WITH THE OFFICER IN CHARGE.
2. CDS 405 OKC, OK STARING 0700 28 APRIL, 2024. PLANNED TO STAND DOWN 30 APRIL 2024 THE EARLIEST.
3. OBJECTIVE: PROVIDE VOLUNTEER AND ORGANIZATIONAL SUPPORT TO AFFECTED AREAS AND MUNICIPALITIES THAT TOOK SUBSTANTIAL DAMAGE DURING THE STORMS 27 APRIL, 2024.
4. QUARTERS ARE NOT AVAILABLE: SET FOR FIELD CONDITIONS. USE STATE FACILITIES IF AVAILABLE, AS DIRECTED.
5. ORGANIZATION MESSING IS AUTHORIZED IN ACCORDANCE WITH APSPERSMAN SECTION 5, SUBSECTION 5. USE OF COMPANY MESSING IS AUTHORIZED TO SUBSIDIZE ANY SHORTAGES OF SUPPLIES.
6. IN ACCORDANCE WITH APSPERSMAN SECTION 3, SUBSECTION 8, UNIFORM OPERATION WILL CONSIST OF CLASS W, WORKING UNIFORM. INSIGNIA AND DESIGNATING MARKINGS MUST BE WORN AT ALL TIMES, INCLUDING OUTER GARMENTS. HIGH VISIBILITY BELTS MUST BE WORN WHEN IN LOW VISIBILITY ENVIRONMENTS.
7. PRESENCE OF SECURITY, AND ARMED PERSONNEL IS TO BE FOLLOWED AS OUTLINED IN APSPERSMAN SECTION 4, SUBSECTION 4. DEVIATION FROM THESE DIRECTIVES WILL RESULT IN IMMEDIATE DISMISSAL, AND DISCIPLINARY ACTION.

8. AREA OF EFFECT: HOLDENVILLE, SULFUR CITY, ADA, AND OTHERS
AFFECTED IN REGION.
